Part A – Artist Application Guidelines

Introduction

The purpose of these guidelines are to:

- explain the Application process for proposed installations at Curiosity Brisbane 2022;
- set out the terms and conditions for participation in the Application process.

These Guidelines are subject to change at the sole discretion of QM.

Application process

The Application process for installations for Curiosity Brisbane 2022 will occur as below.

Stage 1 - Application

Applicants can apply via:

Applications will close on 30 November 2021.

These Guidelines will govern Stage 1 of the Application process. By applying via the link above, the applicant agrees to these Guidelines as they apply to Stage 1 of the Application process.

All costs of participating in Stage 1 will be borne by the applicant. QM is not responsible for any costs and expenses incurred by an applicant arising out of or in connection with the Application process.

QM will not be liable for any late, lost or misdirected entries due to technical disruptions, network congestion or for any other reason.

QM will treat applications as confidential except to the extent that QM is required to disclose applications to sponsors of Curiosity Brisbane, landowners or third parties that assist QM in the review and selection process.

The submission of an application does not automatically grant an applicant acceptance into Curiosity Brisbane.

QM has absolute discretion in the selection of installations to be exhibited at Curiosity Brisbane.

Any decision made by QM will be final. QM is not required to provide any reason or explanation for any decision QM makes in relation to an application or the Application process generally.

Unsuccessful applicants will be notified by email on December 3 2021.

Stage 2 – Commissioning

Selected applicants will be required to enter into an Artwork Agreement with QM. The Artwork Agreement will reflect, among other things, the key concepts set out below.

Selected applicants will be paid a fee by QM in instalments. The fee will be determined via a Request for Quotation. The Artwork Agreement will incorporate the agreed fee.

Neither party will be obliged to proceed if they cannot reach agreement on the fee.

The Artwork Agreement, amongst other things will cover issues to do with Intellectual Property, moral rights, marketing and promotional rights, public communications, and liability.
