

CURIOCITY SCHOOLS CHALLENGE TERMS AND CONDITIONS

The purpose of this document is to set out the terms and conditions for participation in the Curiosity Schools Challenge 2023 application process.

These terms and conditions are subject to change at the sole discretion of Queensland Museum Network (QMN).

Part A – Application Process

Applications

Submissions close 5pm AEST 1 September 2022.

All costs of associated with applying for the Curiosity Schools Challenge will be borne by the applicant. QMN is not responsible for any costs and expenses incurred by an applicant arising out of or in connection with the application process.

QMN will not be liable for any late, lost or misdirected entries due to technical disruptions, network congestion or for any other reason.

QMN will treat applications as confidential except to the extent that QMN is required to disclose applications to sponsors of Curiosity Brisbane, landowners or third parties that assist QMN in the review and selection process.

The submission of an application does not automatically grant an applicant acceptance into Curiosity Brisbane.

Selection

There will be two primary schools and two high schools selected.

Selected schools will be notified by 8 September 2022.

A professional artist will be engaged to work with each selected school to assist in the development of an artwork for presentation at Curiosity Brisbane 2023. The artist will be selected by QMN. The selected artist will have a valid Blue Card.

QMN has absolute discretion in the selection of applications for the Curiosity Schools Challenge.

Any decision made by QMN will be final. QMN is not required to provide any reason or explanation for any decision QMN makes in relation to an application or the Application process generally.

Eligibility

Entry is open to Queensland schools and their associated students registered or enrolled in Year 3 to Year 12 (in 2023). For home-school students, entry is open to children aged between 8 – 18 years old.

Consents

The applicant school must have obtained the necessary parental / guardian consent prior to sharing any images of students in an application.
